Thank you for the open letter on the partnership principle in the Commission's proposal for a Common Provisions Regulation¹.

On behalf of the President and the College of Commissioners, we can assure you of the Commission's determination to defend the objectives of its original proposal on the partnership principle and the European Code of Conduct on Partnership (ECCP) throughout the negotiations. The Commission fully shares your view that good governance of the Partnership Contract and the Funds' programmes is key for their effective and efficient delivery and contribution to achieving the targets and objectives of the Europe 2020 Strategy. This requires the involvement of all relevant stakeholders – public authorities, economic and social partners and civil society bodies – at all territorial levels.

In the Staff Working Document (SWD) on 'the partnership principle in the implementation of the CSF Funds – elements for a European Code of Conduct on Partnership¹³, the Commission services set out that the ECCP would lay down minimum requirements which are necessary to attain a high quality partnership in the preparation and implementation of the Funds while maintaining ample flexibility to Member States in the ways they organise the participation of the different partners. The SWD emphasises that the active and meaningful involvement of all relevant stakeholders - from the very early stages of programme design as well as during implementation, monitoring and evaluation - is crucial for successful implementation and describes how this goal can be achieved.

We are confident that in the new programming period the reinforced partnership principle and the European Code of Conduct will support you in your efforts to successfully implement the Funds' programmes.
